I agree and release Skagit Cycle Center from any and all responsibility of liability for injuries or damages to the user of the equipment listed on this form or to any other person, I agree not to make a claim against or sue Skagit Cycle Center for injuries or damages relating to bicycling or the use of this equipment.

The equipment, at all times, remains the exclusive property of Skagit Cycle Center. The renter is responsible for damage to or loss of the equipment. If the equipment is lost, destroyed or damaged beyond repair, the renter agrees to pay Skagit Cycle Center the value of the bicycle. All repairs needed as a result of the use of the equipment will be performed at normal labor rates and the costs of such repairs, including all parts, shall be paid by the renter.
